Currently, 65.3% of the 2,464 housing units in the area are owner occupied; 22.9%, renter occupied; and 11.8% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 2,469 housing units in the area - 60.6% owner occupied, 29.1% renter occupied, and 10.3% vacant. The annual rate of change in housing units since 2010 is -0.09%. Median home value in the area is \$98,881, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 1.73% annually to \$107,710.
